3. Community Consultation Event

The Hall is now booked for Sunday 26^{th} April 10:30 - 13:00. Place Studio have confirmed that they can make this date. We need to promote it.

Place Studio have provided some suggested wording for the next magazine article, to promote the event. We agreed to use that wording and also to try to get some sort of a housing related image in the article, to make it more eye catching.

4. Work on Objectives

Review objectives published after the last meeting.

Place Studio have provided feedback on our vision and objectives. That feedback was discussed and their changes accepted with the exception of the following wording which was felt to be too much of a generic statement about the whole purpose of a neighbourhood plan.

"Support the delivery of housing in the Parish in response to evidenced local housing need."

John: Add update the vision and objectives document, give it a revision number and circulate it.

5. Progress with the Employment part of evidence gathering

We now have answers from many of the employers, and allocated people to ask the remaining ones. The mapping of these is partially complete.

6. Progress with Local Green Space part of evidence gathering

Place Studio have provided feedback on our initial list.

We should add the triangle of space in Highfield to this list.

John: Add this new potential green space and circulate the list.

7. Initial consideration of Walking and Cycling part of evidence gathering

For recreational walking / cycling it would be great to improve the surface of the track from Netherstreet farm up Beacon Hill. This track is almost unusable on foot for much of

the year as the mud there is so deep, but it is a great route for residents and visitors to access the major landmark in the area.

Our first step is to identify key walking / cycling routes within the village, plus informal paths. Mapping key walking and cycling routes would be a good exercise for the community consultation – we get people to draw routes that they frequently use onto maps of the parish.

The next is to audit the key footpaths. One idea for finding these paths is to merge an old (eg 1850s) map with a current one, to highlight key footpaths. The following website was suggested as a source of historic maps: maps.nls.uk

We should check the Sustrans website for any national cycle routes that may cross the parish.
