5. Green Infrastructure and Open Space Study (10 mins)

So far the Parish Council have been handling this. The PC chair has completed the survey from Wiltshire Council *and* we have requested a copy to understand what the priorities are. We can ask about this at the meeting with the Parish Council.

There was some discussion regarding how helpful it would be to have a Design Policy as part of the NDP, given that the buildings in Bromham don't have a clear style. The conclusion of this was that it could well be worthwhile in helping to preserve certain aspects, such as the open nature of the surrounding fields — by having a policy that blocks the erection of excessively high fences or hedges. Therefore we will instruct Place Studio to carry on with this.
