3. Community Consultation Event

The Parish Council have suggested doing this as part of the Annual Parish Meeting, likely to be sometime in April. However Place Studio have suggested a drop in event that runs over several hours, perhaps on a Saturday.

The meeting discussed the challenge of getting residents to come along to the event. If we make it clear what scale of development might be needed to get the number of affordable houses we need, then that might appear alarming enough to get people to come along...

An alternative approach is to focus on the vision for the parish. So maybe "Is Bromham Stagnating?" would be a good catch-line for advertising the event. This approach was favoured by the meeting

We decided to aim for Saturday 25th April for the meeting, so that we can be confident of being prepared. The ideal venue is the hall in the Social Centre.

Note from after the meeting: The hall appears to be booked from 09:00-10:15 and from 12:00 – 20:00 on Saturday 25th April. So we either need another venue or a different date. The hall is currently free (after 10:30) on Saturday 4th April or Saturday 2nd May.
