Locally Valued Heritage Assets:

Milestone by the Haveli – possible heritage asset, but we don't have any information on this. Similarly - bridge over Stoney Lane – no details as yet.

Review of Hamlet Map

Loop Hill is shown in the wrong place on the map from Place Studio (the area marked is actually New Road). The group felt that it is also appropriate to add Chittoe Heath as s separate hamlet.

3. Base Evidence and Draft Reports tasks needed to be completed

a. **Heritage-** Short listed nomination descriptions and Landowner letters-Catherine & Bryn. Need a shortened version of the history of Bromham to go into the plan.

Has been sent to Georgina in Word format we are awaiting comments from her.

d. **Local Green Spaces-** Public Consultation on-line, Landowner responses-Catherine & John

John: Send Catherine the results from the survey to the consultation report.

WC have suggested that Aster may own the triangle of land in Highfields.

WC have no objection to making the land at the bottom of Church Hill a local green space in the plan. WC also said that this land could be considered for asset transfer to the Parish Council.

e. **Character and Design-** Complete base evidence(character assessment area 6, views and Hamlets) to send to PS- Catherine

f. **Green and Blue Infrastructure Report**- need member to identify which sections they are doing.

Bryn has taken on this report but needs more information about some areas:

Jim: to email Bryn about the management of Roundway Down.

John: Contact the owner of Spye Park to see if we can get information about the management of the park for the report.

Catherine: Ask Pagets & Collins for information to help with the local food production section of the report.

4. Communication / Consultation with residents

a. **The Hoot Article** – deadline Feb 12th for article. Local green space Consultation?

Content: Update on local green spaces. Advertise for new steering group members to help with writing up the plan. Ask if anyone knows about the bridge over Stoney lane. Reminder of the WC local plan consultation.

b. Facebook- Update on posts Local Green Space consultation

WC local plan consultation is out and they have proposed 80 new houses here up to 2036 (13 already built). The consultation runs to 9th March We have posted this on the Facebook but there hasn't been any reaction to it.

c. Website

John: Take down the local green spaces survey.

d. Emails / correspondence

Offer from resident to help arrange hedge planting – forward to parish council. This could potentially fit into the projects section at the end of the NDP.

Letter from a local farmer indicating a need for accommodation for seasonal workers. It was pointed out regarding the second part that the call for sites was closed some time ago and so it is too late in the process to consider that as an option for a site allocation within the NDP.

Victoria Hodgson WC link officer has been in touch and will be meeting with Catherine shortly.

The Parish council requested and have been sent information on all the local heritage nominations.

Georgina sent a summary of the work that Place Studio has done. This can be considered together with the contents of the shared drive. Jim & Greg: pass this to the Parish Council
