3. Draft Neighbourhood Development Plan (30 minutes)

Georgina joined the meeting and talked us through the draft NDP that Place Studio has started. The following points arose from that:

- Sections in red are to be worked on by the steering group, sections in blue are where Place Studio will provide something
- This draft is targeted at the Regulation 14 consultation (when complete), hence includes details of the consultation to that point.
- Section 3 PS have made some changes to the vision, based on comments from consultation and have reorder the objectives. So we need to review and comment on this.
- We should add something related to local agriculture / horticulture to the list of possible policies, as this is a key feature of the area.
- Place Studio plan to do some more work on green infrastructure and biodiversity as this hasn't yet featured much in our evidence gathering.
- Section 6 Projects these are not part of planning policy, but are a good opportunity to declare projects that the parish council or community groups would implement over the period of the plan.
- We will allocate different people to work on different areas and those people will provide text and comments to Place Studio.

4. Feedback from Parish Council on review of AECOM & Place Studio site suggestions

We should get minutes of the meetings from Rosalind tomorrow. Once we have seen these we can revisit the process of site selection.

5. Evidence Gathering

a. Heritage, Conservation area, call for Sites, Tree strategy, nominations-Rachel, Catherine

Georgina advised on the level of detail to have in the history part of the heritage report.

Tree strategy is really the responsibility of the Parish Council, so could form a project in the NDP rather than a policy. Apparently the PC doesn't currently have a tree officer.

Catherine: contact the PC about a tree strategy.

Catherine has made a long list of possible heritage items which have been nominated. Some of these are already listed or protected and so could be discarded as we work towards a shortlist.

b. Pavements Audit-Peter

Peter has walked all of the paved footpaths and has written a draft audit report, which he will circulate together with a set of photographs.

c. Character and Landscape- Mel

Mel not present so no update

d. Local Green Spaces- Catherine landowner letters

Catherine has drafted the letters. Georgina suggested an amendment to the line saying "consult later in the year" to "in the coming months. Paragraph 1 page 2.

Catherine: to send a set of draft letters to the Parish Council asking them to approve and send out the letters to the landowners.

e. Character and Design- Place Studio

Hamlets – We should check the suggestion map from PS and let them know if it is appropriate. The important point is to assess how they sit within the landscape.

A number of top-up activities suggested by Place Studio are documented in the Nov 2020 Next Steps Briefs subfolder. Each likely to take an hour or so in a car with a camera. These are best done by people with local knowledge and could involve people outside of the steering group.

- 1. Steeple Chasing activity to map places where you can see the steeple
- 2. Serial vision capturing the experience of entering and travelling through the village on key routes.
- 3. Key views creating a collection of key views in to, out of and within Bromham
- 4. Beating the bounds looking at the village within the broader context

We will agree via email who is going to tackle each area.

6. Communication / Consultation with residents

a. The Hoot Article

The next article is due on the 9th December.

Catherine: to write something based on the walk around the conservation site and the heritage. Also mention that we are now working on the character and design.

b. Facebook

There have been lots of posts on the heritage theme over the last month.

c. Website
