- JB has asked the Crown if there are any covenants on the land.
- Patch of land (1 Acre) on the Millenium field that is not owned by the Parish council, owner of land to be contacted (already numerous attempts to contact owner by the PC)

## 3. Workstreams Reports

- Design survey responses (Peter and Adam)
  - 138 Survey Responses (84 Online and 54 Offline) with a couple of offline still to add.
  - Still going through the results and categorising but some recurring feedback picked up so far;
    - Building/decor being outdated (Some did point out this is to be expected for a 50 year old building).
    - Hall bar being too small for big events.
    - Hall kitchen being improved to catering level.
    - The Stage is the most debated item with some saying how important it is and others saying it was a waste of space.
    - Making more of outdoor space / having patio/decking area etc
    - More meeting rooms / Ability to split hall into smaller spaces.
    - Not building related but business wise Lots of mentions of cafe by day / pub by niaht.
    - Quite a lot of local halls mentioned but Market Lavington brought up the most by far.
- Some complaints that the form was too complicated.
- Decided to keep the survey response open.

- Build Sue, update
- Large hall with sub division into smaller rooms a possibility?
- Short Matt bowls need a space the same size, so number of occupants isn't the only indicator of room size.
- Retractable seating an (expensive) option for the stage area?
- Acoustics were terrible in the old social club, stage was too high.
- Requested red line drawing, layout of sports pitches from the PC.
- High level master planning to confirm which area of land we are/can use.
- PD to approach Matt Reed for Topological survey to assist in the PITT document.
- Funding Income and Expense SW (Donations to date £4725.65)
- KA donation paid into the account, thank you again greatly appreciated.
- No response from RH on the finances.
- Lottery funding approached (no response to date)- grants have been awarded in the last 3 years, not many 1.1 million highest for village hall. 'A generational building, for the community.'
- PD Landfill tax, community first, every year they have a fund that can be applied for.
- SW A matrix should be produced by looking at previous grants and how they worded their application.
- Dyson DF has contacted them with regards to the Dyson Fund, awaiting response.
- GP to collate the grant information/workflow.
- We don't think we can realistically cannot apply for grants until we have our budget.
- Legal and Insurance update from Ross
- No response from AXA, roofer has sent notice of claim letter to their lawyer.
- Legal and Policy Liability.
- A Reinstatement cost report is being finalised and will be passed to RPC.
- Clubhouse report from Social Committee
- MT No issues to report. Key lock fitted.
- Hygienic bin fitted for ladies WC, contract with initial.
- Fencing moved.
- Plenty of bookings for next year.
