# Insurance claim update - RP

- Following approval from the Parish Council the Rebuild committee have requested to draw down the remaining facility from Aviva. We are awaiting a response from their senior loss adjuster.
- Our solicitors are progressing the claim and due to take significant next steps shortly which we
  hope will provide clarity as to our likely settlement. Progress is slow but there is a lot of work
  behind the scenes in preparing for the next steps'

#### 3. Workstream Reports - Various

## • Building Design

Had a very interesting concept design meeting, we are not currently in a position to formalise a design, however looking how the place may look, in regards to layout. A list was created for 'design parameters'. (Handout was produced, attached). These go hand in hand with the results from the village survey, e.g. community pub area, large hall, similar design. It was suggested by the Chair and agreed unanimously by the Rebuild Committee that these be collated and put forward to the Parish Council. Item has been added to the next agenda, for showing design parameters, survey results, and historic data on bookings.
