## Insurance Claim Update

AXA and mr Stevens, made contact with solicitor to try and negotiation on his behalf, the purpose being to find out how far he took the complaint with AXA. Initially he instructed a loss adjuster who he thought were solicitors. End result is perhaps to take it to the financial ombudsman

JB looking at the insurance the PC took out, as far as can be seen, might be able to take blame, allied Westminster taken out in September 2020, indemnity cover for £500,000 to cover the trustees, trustees indemnity cover. Is there a chance we could say, the trustees gave the contract to the roofer, there wasn't proper due diligence, is there any scope for claiming of the indemnity insurance? RP - doesn't think the management committee were responsible for instructing Mr. Stevens, doesn't think we would get that far perusing that route.

#### Grant Bids

Originally told we cannot bid for a Jubilee grant, but have now been told we can but will have to become a CIO. PH Department for levelling up states we need to change our status, big advantage is its limited by Garuntee, unlike at the moment its the trustees, it can enter into contracts in its own right. Relatively simple structure to set up, how many trustees do we have, or do we go for a membership (e.g all members of the village are members and can vote in trustees). You can have as many trustees as you like, recommend between 5 and 9. Trustees cannot be employees. The date the structure is changed is key due to the Parish council.

#### • New Hall Charitable status

All present members of the rebuild committee agreed they don't see any negatives to perusing this above structure and it will be proposed to the Parish Council. Seconded RP - Unanimous.
